AN ORDINANCE RESTATING BOROUGH STREET ORDINANCES TO MORE ACCURATELY DESCRIBE THE PUBLIC STREETS WHICH THE BOROUGH MAINTAINS

The purpose of this Ordinance is to enable the Borough of Alexandria to receive its full allocation of Pennsylvania Liquid Fuel Tax Monies
